TERMS AND CONDITIONS

1. Authenticity	The seller guarantees that the bag offered is authentic and free from third-party ownership rights. JOMB reserves the right to refuse a bag if authenticity cannot be established.
2. Consignment	In case of consignment, JOMB sells the bag on behalf of the seller. The agreed remuneration will be paid within 5 business days of receipt of payment from the buyer. The consignment period is 90 days by default.
3. Direct purchase	In case of direct purchase, ownership of the bag transfers to JOMB upon signing and receipt of the bag. Payment will be made within 3 business days of receipt and approval.
4. Shipping to JOMB	The seller is responsible for safe shipment of the bag to JOMB, preferably by registered and insured post. Shipping costs are borne by the seller unless otherwise agreed.
5. Condition of the bag	The bag must correspond to the description and condition provided by the seller. In case of discrepancy, JOMB reserves the right to revise or cancel the agreement.
6. Return if unsold	If the bag has not been sold after the consignment period, the seller will receive the bag back. Return shipping costs are borne by the seller.
7. Price adjustment	In consultation with the seller, JOMB may adjust the sale price to facilitate a sale. JOMB will always inform the seller in advance.
8. Liability	JOMB takes care of the bag while it is in its possession. In case of loss or damage caused by JOMB, reasonable compensation will be paid up to the agreed value.
